

## Deposit a Miniskip/Container on Council Land

## **Conditions of Authorisation**

- 1. Safety warning devices are to be installed at the applicant's expense, including *flashinglights/reflective bollards* at each corner of the waste bin/container and are to be in good working order and operational from sunset to sunrise;
- 2. Approval shall only be issued where on-site placement is not possible or practical;
- 3. No skip/container shall be placed on Council land without an application being approved;
- 4. The applicant accepts responsibility for any damage to road and footpath surfaces or any other damage on public land as the result of the bin placement or removal;
- The applicant accepts responsibility that any damage caused as a result of the skip/container must be reinstated to the satisfaction of Council at the applicant's expense;
- 6. Bin/container placed adjacent to the subject property in an area approved and specified by the City of Burnside in accordance with the plan submitted with the application;
- 7. The area surrounding the waste bin/container must be kept free of debris (overspill) at all times;
- 8. Authorisation is not transferable and is valid for the term identified in the application;
- 9. For the term of the Authorisation, to take out and keep current a public liability policy of insurance to an appropriate level of cover (20 million dollars or as may be varied from time to time) in respect of any negligent act or omission of the Applicant in relation to the placing of the bin or any activity arising out of or from the granting of this Authorisation by the Council;
- 10. Applicant agrees to provide Council with a copy of the valid Public Liability Insurance;
- 11. That no responsibility will be taken by Council for the placement of "materials" in the "skip/container" by unauthorised person/s;
- 12. The structure and its construction shall not interfere with or cause any damage to or affect in any way any wire post, cable pipe or other thing the property of ETSA Utilities, Telstra, SA Water and/or United water, Boral, Origin Energy Limited or other Federal, State or Local Government Department or authority;
- 13. This authorisation will not be effective until the Applicant has received a signed permit issued by the City of Burnside;
- 14. This authorisation does not confer on the applicant any exclusive right, entitlement or interest in the road;
- 15. To indemnify the Council, its servants and/or agents against all actions, costs, claims

and demands for injury, loss or damage arising out of any negligent act or omission of the Applicant in relation to the placing of the bin, the granting of this Authorisation and the general and special conditions contained herein and such indemnity shall be in addition to any statutory immunity in favour of the Council;

- 16. The applicant must comply with any Act of Parliament, Regulation or By-law relating to the use of the road;
- 17. Application fees for 2023/24 financial year are:
  - 17.1. Skip Bin Permit
    - Standard 14 Day Permit \$110.00 (more than 3 business days' notice)
    - Urgent 14 Day Permit \$150.00 (rapid processing, less than 3 business days' notice)
    - Extended 7 Day Permit \$70.00 (per week or part thereof)
    - Lost Permit/Permit Re-issue \$15.00
  - 17.2. Shipping/Storage Container Permit
    - Standard 7 Day Permit \$275 (more than 14 days' notice)
    - Urgent/Rapid 7 Day Permit \$400 (per week or part thereof)
    - Extended 7 Day Permit \$350 (per week or part thereof)
- 18. Breach of any these conditions will result in further action by the City of Burnside including and not restricted to the issue of explations or cancellation of the permit.
