

## Burnside Street Names and their Origins

*Inez Court*

*Rosslyn Park*

### Origin of present name

Named after Inez Kathleen Hyland (1863-1892).

Inez Hyland was grand daughter of Dr Christopher and Mary Penfold who for years lived in *The Grange* in Penfold's vineyards. The Rosslyn Park area was also part of the Penfold estates.

### Origin of present name

Named after Percy Ifould.

Percy Ifould who was Manager of the Dunstan Quarries owned the property *Kurralta*, through which this road runs, from 1918 to 1968.

### Origin of present name

Named after *Ilfracombe House*.

Forty acres in this vicinity were bought in the 1840s by Dr James Nash (1805-1880) and the house *Ilfracombe* was built. He bought a further forty acres to the north in 1851. One of his sons Heath was on the John McDouall Stuart exploration of 1861-1862 and later landlord of the Sussex Hotel at Port Adelaide.

In 1856 Dr Nash returned to England and the house had a series of tenants including John Hallet who moved from Stonyfell House. From 1870 to 1877 it was used to house destitute and criminal children who were moved later to the Magill Orphanage. The house deteriorated and a few years later the estate was bought by Joseph Crompton of Stonyfell and his brother-in-law Sidney Clark. The land was subdivided leading to the subsequent creation of the estates of *Bell Yett* and *Chiverton* (now St Peter's Collegiate Girls School).

In 1888 the house with eight and a half acres was bought by Henry Martin (accountant and later owner of Stonyfell Winery) and went through a number of uses including the head office of H. M. Martin & Son, Stonyfell Vineyards until it was demolished in 1960 and the land sub-divided.

*Inverness Avenue*

*St Georges*

### **Earlier name(s) if different from present name**

Roxburgh Avenue, Burnleigh Avenue.

### **Origin of earlier name**

### **Origin of present name**

Probably named after the town in Scotland.

The Tweedie family who owned the land south of the junction where this road joins Blairgowrie Avenue originated from Scotland. The land was subdivided in the 1920s.

However the land is mainly on the estate of *Highfield*.

Malcolm Tweedie a metallurgist from Scotland, owned *The Croft* and land down to Portrush Road.

The house was located on the lower side of Sunnyside Road near the corner of Dashwood Road where the creek passes by. The estate was mainly a 67-acre apricot orchard and when it was subdivided a number of the local streets were given Scottish names.
