Origin of present name

Named after Simpson Newland.

Simpson Newland was owner of the nearby house and estate *Undelcarra* between 1876 and 1911. The estate stretched north from Second Creek, between Lockwood Road and Hallett Road up to approximately where Statenborough Street is now located.

Simpson Newland's father Ridgeway Newland was the pioneer minister who arrived in 1839 with his dedicated congregation and established a settlement at Yilke on Encounter Bay - later to become Victor Harbor. His son Simpson was one of the first sheep station owners on the River Darling in New South Wales and later settled in Adelaide where he became a political and civic leader.

He is famous for writing the Australia classic *Paving the Way* about the whaling in the Victor Harbor area.

Final subdivision was in 1969.

Nilpinna Street Burnside

Origin of present name

Unknown.

Probably Aboriginal. Possibly having some connection with the locality *Nilpena* near Beltana. The house and estate of *Ivymeade* which are accessed along this road were once associated with two mining captains:

- Captain Henry Hancock (1836-1919) from 1898 after he retired from Moonta Mines until his wife died in 1930
- Captain William White from 1930. His daughter remained in the house until 1979.

Either of these captains may have looked into mining interests which were also under consideration in the Beltana area.

The stone stable from *Ivymeade* can be seen further up the road where it has now been converted into a private house.

Probably named after the County of Northumberland in England.

John Hunt (1800-1860) arrived from Heathpool, Northumberland in 1838 and leased 67 acres of the southern part of Section 299 in this vicinity from the South Australian Company. He ran a dairy farm calling it *Thornington* and then bought it in 1853. When John Hunt died in 1860 his wife and daughter sold up to developers and returned to Northumberland.

Their small pisé cottage was near where Statenborough Street crosses Second Creek today.

Nursery Lane
