# 1. Introduction

- 1.1. The City of Burnside is committed to celebrating our city's rich history and heritage, to maintaining and enhancing its unique historic character and to ensuring that our built and natural heritage and historic character streetscapes are preserved, maintained and promoted for current and future generations.
- 1.2. Heritage plays a key role in enriching our community member's lives socially, emotionally, physically and spiritually. The City of Burnside recognises the importance that heritage contributes to the overall community wellbeing.
- 1.3. Heritage items and places are the City's 'autobiography'. The conservation of built and natural heritage gives the community a sense of historical

perspective, a framework for future development, recognisable links with people and events in history, providing a sense of community pride and stability in a rapidly changing world.

1.4. Heritage conservation is about making the most of our built and natural 'inheritance' and is based on the idea that we are custodians of the natural and built environment for future generations.

### 3. Our Approach

3.1 This policy addresses all places and items of heritage value including, but not limited to, buildings, mines, monuments, reserves, gardens, street furniture, infrastructure and trees.

- Heritage items and places will be seen as assets which positively contribute to our City's unique character and identity.
- 3.3 Heritage conservation and management will be seen as activities which positively contribute to our City's wellbeing for the benefit of current and future generations.
- 3.4 This Policy aims to:
  - 3.4.1 Identify, promote, preserve and enhance our heritage and history within the City of Burnside.
  - 3.4.2 Guide decisions and actions within the City of Burnside in order to support the conservation of the City's built and natural heritage.
  - 3.4.3 Guide services and programs which support heritage management within the City of Burnside.
  - 3.4.4 Assist property owners, community groups, industry and government in the management of built and natural heritage.

# 5. Interpretation

- 5.1 For the purpose of this policy:
  - 5.1.1 "Heritage" refers to both built and natural heritage
  - 5.1.2 "Policy" is a Council Policy
  - 5.1.3 "Kaurna heritage" is the legacy of tangible and intangible belongings transmitted by or acquired from previous generations of the Kaurna People, the traditional owners of the Adelaide Plains. This heritage can include traditions, artefacts, language, places and ancestral remains that are of importance to the Kaurna People.

#### 6. Policy

- 6.1 The City of Burnside will seek to:
  - 6.1.1 Conserve, preserve, restore and maintain the City's built and natural items and places of heritage significance.
  - 6.1.2 Value, respect and promote our Indigenous cultural history and intangible heritage, liaising with the Kaurna People.
  - 6.1.3 Maintain and promote Kaurna heritage in coordination with the Council's Reconciliation Action Plan.
  - 6.1.4 Act as custodian for heritage assets in public spaces (the public realm), through their identification, management and enhancement as part of public works.
  - 6.1.5 Manage and maintain council owned heritage buildings and items of heritage significance including buildings, reserves, infrastructure, war memorials, monuments, mines, street furniture, trees and other assets of heritage value.
  - 6.1.6 Ensure the conservation of the City's built and natural heritage is an integral part of Council's asset management planning and practices and guides Council's decisions and actions.
  - 6.1.7 Advocate to State Government bodies for legislative policy which supports conservation of built and natural heritage.
  - 6.1.8 Participate whenever possible, in the formulation of national, state and local legislation and policy affecting heritage items and areas within the City of Burnside.
  - 6.1.9 Advocate at the state and national level for support for the retention and conservation of buildings and items of heritage value.

6.1.10 Consistently and accurately interpret and apply the aims, objectives and policy of heritage conservation and management within legislative instruments.

- 6.1.11 Encourage property owners to conserve and enhance privately owned items of heritage significance through education, professional advice and/or incentives.
- 6.1.12 Encourage property owners and developers to consider, where appropriate, adaptive re-use of heritage buildings and development which is sensitive and respectful of the surrounding built heritage and historic character.
- 6.1.13 Facilitate staff awareness and appreciation of the value and importance of our City's heritage.
- 6.1.14 Foster community awareness and promote the value of heritage items, buildings and historic character streetscapes through effective promotional and educational activities.

#### 7. Review and Authority

7.1 This Policy will be reviewed every four years at maximum in line with Council's Policies and Protocols Framework.
