

# Mayor's Message

#### **Gurney Road Reserve**

A long running issue involving Rose Park Primary School, The Department of Education and Training (DPTI), the City of Burnside and local Rose Park residents concluded at the first Council meeting in 2017.

In the suburbs of Dulwich and Rose Park, Gurney Road ran north/south from Dulwich Avenue to Kensington Road up to the 1980s. Between Grant Avenue and Alexandra Avenue intersections with Gurney Road, the Primary School was to the immediate east and the former Rose Park Uniting Church to the immediate west

In the 1980s, both as a traffic control measure and to provide the school with more open space, Gurney Road was blocked to road traffic between Grant Avenue and Alexandra Avenue. The road to the north was renamed Victoria Terrace. The school entered into a lease with the City of Burnside to use the road space as school grounds and acquired the former church to use as a classroom.

Public access to the road reserve (Gurney Road Reserve) as a thoroughfare between Alexandra Avenue and Grant Avenue remained unrestricted, although the area was fenced and gated.

In recent years, this uncontrolled public access during school hours became a matter of concern to both the school and DPTI as a child safety issue. It is against DPTI policy to allow public access to school premises during school hours and Rose Park Primary School was the sole remaining school in the State which did not comply with this policy.

Several years ago, the City of Burnside was approached by DPTI and the school and requested to act to restrict public access during school hours. The matter then became subsumed by the broader issue of Burnside acquiring from the State Government the open space in Leabrook known as Constable Hyde Reserve, which the State had

targeted for high rise development. A swap with the State Government of Gurney Road Reserve for Constable Hyde Reserve was considered.

However, Burnside does not have the power to act unilaterally on such matters. Where community land is concerned, the City is required to formally consult local residents on proposed significant changes and Council is bound to take the results of the consultation into consideration.

The land swap issue was extensively canvassed throughout Burnside and it was concluded that the citizens of Burnside had no appetite for relinquishing ownership of Gurney Road Reserve but wanted Burnside to continue with the purchase of Constable Hyde Reserve.

This will now occur. With Burnside committed to retaining ownership of Gurney Road Reserve, a second formal consultation process was conducted on the issue of public access during the latter part of 2016. The essence of the debate, in which there was a high degree of community participation, was community right of access on one hand and child safety obligations on the other. Both sides had strong defenders of their respective positions.

The matter came before Council in January before a packed public gallery. As Presiding Member of the meeting I allowed deputations to be presented by eight residents, four representing each side of the debate.

Council resolved to accede to the DPTI and school request and public access to the reserve is now restricted to before 8 am and after 4 pm on school days. There is no restriction on weekends, public holidays and during school holidays. This decision was consistent with the clear outcome of the community consultation -77 per cent support. As Presiding Member I vote only when a matter is tied on the floor - a casting vote and it was not required on this issue.

This long-running story is a good example of decision-making in local government. Nothing proceeds quickly as strenuous efforts are made to include the community in the process. Often decisions are required on matters on which there are diverse community views and most decisions leave some members of the community dissatisfied. Local government, as the level of government closest to the community, is the easiest target.

As a Gurney Road resident I often used the Reserve thoroughfare to access shops on Kensington Road. Nevertheless, I support the Council decision. I am aware that my neighbours and many friends in Gurney Road and surrounding streets were divided on the issue. The decision having been made, however, disappointed members of the local community have accepted the outcome without complaint. I sincerely thank them for this mature and understanding attitude.

#### Tour Down Under

Council recently resolved not to pursue hosting a Tour Down Under stage event in 2018. The decision was based both on cost as well as the lack of a Burnside main street location to take full advantage of the event.

I volunteer with TDU every year and fully appreciate the remarkable benefits that it brings to the communities of SA. Beyond 2018 Burnside will investigate co-hosting with the City of Campbelltown to host a stage event on Magill Road to showcase the Magill Village plans.

Rangers provide a variety of services to the community including parking control, outdoor dining regulation, general animal management and bushfire risk management.

They also manage Council by-law compliance for advertising and signage, dog exercise areas and activities, and for the use of public spaces like our parks and gardens.

Senior Ranger Davin Thompson says Rangers deal with a diversity of things. "We are almost the call centre of the front line," he said. "Our three main responsibilities are animal management, fire prevention and parking control."



### 🄯 Animal Management

Rangers deal with a variety of animals, from cats and dogs to koalas, foxes and possums but they do not have the capacity to deal with kangaroos. Dog management is one of their core roles and Davin reminds dog owners they must register their pets and should also microchip them. "Registering and microchipping allows any Council to identify your dog if it strays across borders," Davin says. "It also means a discount on your registration, so if you change address or ownership of a dog, let the Council and Microchip company know so your details are always up to date."

In 2015/16 the Rangers picked up 60 stray dogs and all but one were reunited with their owner.

All Burnside parks are dog friendly but Davin says it is important to remember the rules. "You must have your dog on a lead on roads and footpaths and in our parks they must be under effective control such as voice command." There are serious penalties if your dog is wandering at large or if it attacks a person, animal or bird. And don't forget to pick up your dog's poo.



### Fire Prevention and Preparation Parking Regulation



Fire season is almost over but residents still need to be diligent. The unseasonal heavy rain has caused lots of growth in summer and when long grass dries off it will be a fire hazard.

"As we near the end of the fire season now is the time to start thinking about preparing for the following fire season," Davin said. "Our Fire Prevention Officers will inspect properties and can give advice on managing growth."

For residents living in the Hills Face Zone, Council allows for controlled burning outside of the fire season. Davin says a permit is required and residents should apply well before they intend to burn. "We won't approve it if we believe alternate measures would be more appropriate," Davin said. Penalties apply for any person burning without a valid permit.

Burnside Council operates under the Adelaide Mount Lofty Ranges Bushfire Management Area Plan. The Plan, developed by the CFS, covers all aspects of bushfire prevention for the City of Burnside.

Davin says it is important for residents in the Hills Face Zone to be vigilant about fire prevention. "Above all, make sure you have a bushfire plan and practice it often. We are keen to work with residents in the Hills Face Zone to ensure a safer environment for all."

An important role of the Rangers is to enforce parking controls and laws set by the State Government (Australian Road Rules). While there will always be some complaints about individual parking tickets, there are many other residents and ratepayers who appreciate having controlled access to parking in their streets, particularly in parking 'hot spots' and in areas where residents don't have off-street parking. Davin says there are easy ways to avoid a parking fine. "Check the sign on the roadway or car park and if you're not sure, move on," Davin said. "If you park in a time limited space, ensure you note the time and return to your vehicle before the time is up. Don't park in a 15 minute zone if you know you will not be back for at least an hour."

#### One of the highest parking expiation fees is for parking in a disability car park without displaying a permit (\$355).

These spaces are allocated to make it easy and safe for people with a disability to reach a building. They are usually close to the entrance and are generally wider than the average car park to facilitate the movement of wheelchairs and mobility devices. "If you have a permit and do not display it you may still be fined as the Rangers won't know," Davin said.



Ranger Services is an important part of Council's workforce and they undertake a huge variety of tasks all aimed at ensuring those who live, work and play in the City of Burnside are safe, and that Council facilities and amenities are enjoyed by the community without unnecessary disruption.

Eastern Health Authority (EHA) is a subsidiary of five councils - Burnside, Campbelltown, Norwood, Payneham and St Peters, Prospect and Walkerville – and serves to protect the health of these communities.

EHA has a major role in environmental health (eq checking water quality in public swimming pools and spas; ensuring safe hygienic practices of hairdressing and beauty salons, acupuncture clinics and tattoo parlours; investigating disease outbreaks in conjunction with SA Health; investigating incidents of pest infestations, insanitary conditions, and substandard housing).

EHA plays an essential role as the provider of immunisation services, in council clinics and in school and workplaces. Immunisation is an essential service that attempts to protect children and adults against certain diseases and minimise the spread of infectious diseases. EHA regulates and provides health information to food businesses, investigates complaints and conducts food safety checks at restaurants, cafes, special events and other food service outlets. EHA also provides regulatory services and inspections of Supported Residential Facilities.

Increasingly SA Health has moved the responsibility for community health to local government. As a result, a Regional Public Health and Wellbeing Plan was developed, called Better Living Better Health. I have been a Board member of EHA for six years (along with Councillor Cornish) and am currently Deputy Chair.

As we live our unusual summer with extremes of temperature, rain and windy sudden weather changes, Council staff have been doing a fantastic job across Burnside helping our residents and businesses manage the outcomes – flooding, fallen trees, debris and litter build up, erosion - while trying to maintain their scheduled services.

We all live here because we value our green, leafy environment and beautiful streetscapes. I am heartened to see residents across Burnside spontaneously supporting their community and the administration by helping to water street trees especially young ones - helping remove and keep weeds down around their property boundary, mowing verges, sweeping up leaves and debris, cutting back hedges and any branches which overhang footpaths. I urge all of us to help where possible with these chores when resources are stressed and to help us contain costs.

I am concerned that Council's 2016 Tree Canopy Assessment has identified that tree cover in Burnside has decreased significantly, with nearly 45 per cent of the city now covered with non plantable surfaces such as buildings and roads due to the loss of 10 per cent of our trees. This has many negative effects on our environment, health and quality of life, our fauna and bird life and even our property values.

Council will soon consider what strategies we can put into place to address this reduction in tree canopy cover.

# Rose Park & Toorak Gardens Ward

The decision of Council to prevent public access to Gurney Road Garden from 8 am until 4 pm on school days was disappointing to residents of Rose Park, for whom the thoroughfare is most relevant.

It was claimed that the exclusion of the public was required in the interest of child safety, but local residents disputed this as the school had supervisory methods in place, and additional options were feasible.

Local residents lament that a more equitable solution was not achieved, and this emphasises the need in future to exhaustively pursue Community Land Management Planning.

Their exclusion is particularly a paradox as Council only a few months ago agreed to pay approximately \$250,000 to the State Government to have Gurney Road Park excluded from the Constable Hyde Park land exchange to retain it as community land.

Over coming months the Local Nuisance and Litter Control Act (2016) will empower local government to manage local nuisance, littering and dumping, in conjunction with the Environment Protection Authority.

The powers delegated to authorised officers are extensive and penalties potentially enormous. Failing to cooperate has a maximum penalty of \$10,000, and activities creating a local nuisance will have a maximum penalty of \$10,000 (\$20,000 for a body corporate) and an expiation fee of \$500.

Please contact Council for advice if you are unclear about hard rubbish collection or other matters relating to these powers which will be delegated to Administrative staff.
