



George Bolton Swimming Centre Burnside Conditions of Entry

- 1. Patrons must pay the applicable entry fee to enter the Centre.
- 2. Patrons must obey the directions of Centre staff and signage at all times.
- 3. The Centre is a 'Watch Around Water' endorsed pool. These rules must be adhered to by patrons at all times within the Centre. These rules can be viewed in the foyer area and on the City of Burnside website.
- 4. Children will be allowed to enter the Centre if they are accompanied by a parent or by a guardian who is over 16 years of age. Children who are between the ages of 13 and 16 and who are not accompanied by a parent or guardian will be allowed to enter the Centre only if they show a current student identification card verifying their age to Centre staff. Children under the age of 13 who are not accompanied by a parent or guardian will not be permitted entry to the Centre.
- 5. Concession entries, including concession pass holders, are only valid for use by concession card holders, children, and spectators. Patrons claiming concessions may be asked to produce their concession card upon purchase of any concession entry or concession pass.
- 6. The Centre may need to close or restrict access for a period to the public for various reasons such as events, overcrowding, inclement weather, emergency, breakdown etc. Pass holders will not be entitled to extensions on pass expiry dates because of these situations.
- 7. Recognised swimwear must be worn at all times within the Centre.
- 8. Non-toilet trained infants must wear recognised aqua nappies in the water at all times. Regular nappies are not suitable for use in public pools. Nappies should be changed in family change rooms and disposed of in the nappy bins provided.
- 9. Behaviour or language that is deemed by Centre staff to be offensive, aggressive, disruptive, unsafe or abusive will not be tolerated.
- 10. Any patrons who are or appear to be under the influence of alcohol or drugs will not be permitted into the Centre.
- 11. Glass objects or alcohol are not permitted in the Centre. Bags and belongings may be searched upon entry to the Centre.
- 12. The Centre is a 'Smoke Free' venue. Smoking and/or Vaping is not permitted within the Centre.
- 13. Cameras and other photographic devices are not permitted in the change rooms. Patrons are permitted to use photographic devices on the provision that they have permission from the person(s) they are photographing/filming and are not deliberately including other people who have not provided permission in their photographs. Patrons must cease photographing/filming immediately where directed by staff where a complaint is made by another patron.
- 14. The Centre has both video and still surveillance cameras operating at all times. Entry into the Centre gives Management the right to use images taken for security and investigation purposes.
- 15. The Centre accepts no responsibility for lost or stolen belongings at any time. Patrons are advised not to bring valuables to the Centre if they will or will likely be left unattended. Lockers are available within the Centre to secure belongings.
- 16. With the exception of assistance dogs, pets and animals are not permitted in the Centre.
- 17. Only persons approved by the Centre are permitted to conduct coaching and private swimming lessons at the Centre.
- 18. Patrons must not sell any goods or services or give away political, religious, advertising or promotional materials without the Centre's consent.
- 19. Patrons must not conduct public surveys or opinion polls or solicit money, donations or subscriptions from members of the public.
- 20. Patrons enter the Centre at their own risk. It is the patron's responsibility to enter the water where they are medically and physically fit and able to swim.
- 21. Management reserves the right to refuse entry.
- 22. There are no pass-outs available at the Centre.

Refusal to comply with the above Conditions of Entry may result in the removal of the offender from the Centre without refund.
